If export consignments are removed from the factory of manufacture, following the AR4 procedure, claiming exemption of excise duty, there is an obligation cast on the exporter to provide proof of export to the Central Excise authorities STEP 7: Documents for C & F agent : The Exporter is expected to provide the following documents to the Clearing & Forwarding Agents, who are entrusted with the task of shipping the consignments, either by air or by sea.

The first scheme is to make payment of the excise duty at the time of removing the export consignment from the factory and file a claim for rebate of duty after exportation of goods. The second scheme is to remove goods from factory/warehouse without payment but under an appropriate bond with the excise authorities.

Export Clearance Procedures 1.1 Lodging an Export Declaration: The first stage of the export clearance procedure is to lodge an entry (Customs Form 15) through the EDI system. The entry can only be lodged by a licensed customs agent authorised in writing by the owner of the goods to act on his/her behalf.
