To reply to a letter or notice securely, log in to your Online Services account and use our Respond to Department Notice online service. It's the easiest and fastest way to provide the Tax Department with additional information. Depending on the notice you received and your response, you may need to attach scanned documents.

How to Respond to a Tax Department Notice or Letter

When your tax return doesn't match income information the IRS has (like Forms W-2 and 1099), the IRS sends a notice. It's usually a CP2000 notice, also called an underreporter inquiry. This notice basically proposes taxes, and possibly penalties, you might owe for missing income on your return.

Respond to a letter requesting additional information

If you have received a mail from the Income Tax Department by post, then you need to reply to the authority that sent the notice, giving detailed reasons for not filing the ITR. If you did not file ITR because your income was below the taxable limit, then mention this in the letter.

How to Reply to different Income Tax Notices

A Notice of Income Tax Assessment (NITA) is issued when there is no response to an initial notice or when a tax liability is not resolved on the unpaid tax. Appeal rights are provided on this notice.
