New York Produce Exchange form (NYPE). This standard form time charterparty was approved by the New York Produce Exchange when it was first published in 1913. Amendments were made in 1921, 1931 and 1946. The last amended form of the charterparty is still current, perhaps because shipping people are familiar with it.

With modern paints and ship technique, the provisions in Clause 21 of the NYPE 1946 requiring shipowners to drydock the vessel "at least once in every six months" has become obsolete. A modern solution which reflects present-day practice, is now offered in Clause 19 and leaves it to the parties to agree between themselves as to whether option (a) or (b) shall apply.
