The authors state that pension plans have two main objectives: (1) Smoothing of consumption, i.e. enabling one to save for one's old age; a related subobjective is providing insurance against running out of money if one lives longer than expected (2) Redistribution of income among different age groups (cohorts), and other classes of people in a society (or company); a related subobjective is alleviation of poverty.

Since 1 October 2015, members of occupational defined contribution pension schemes are no longer entitled to short-service refunds if they leave employment (or opt out) with less than two years ' qualifying service. Those with less than 30 days service will still be able to request a short service refund of just their contributions less tax.
