*Investigative interviewing*

This can be a difficult offence to prove, and it should be reserved for the more serious cases. Where it is doubtful whether the threat carried the necessary intent a charge under s.4 or s.4A Public Order Act 1986 (see Public Order offences incorporating the Charging Standard ) or other offences such as at s.1 Malicious Communications Act 1988, s.127 Communications Act 2003 may be appropriate.

The elements required to be proved are widely ...

It is necessary to prove that the conduct is unacceptable to a degree which would sustain criminal liability, and also must be oppressive (R v Curtis [2010] EWCA 123). These offences are usually easier to prove than handling (as dishonesty is not an element of the offence and mere suspicion may be enough to prove mens rea.) However, they should not be used simply as a way of allowing the prosecution to avoid its burden where the conduct involved is sufficiently covered by the handling provisions (see R v GH [2015] 1 WLR 2126 at paragraph 49.)
