In the header of each page you include the paper title and page number. If your paper title is longer than 50 characters you should use a shortened version as running head. The page number should be positioned in the top right-hand corner. On the title page the APA running head is preceded by the words "Running head:".

Consistency in the order, structure, and format of a paper allows readers to focus on a paper's content rather than its presentation. To format a paper in APA Style, writers can typically use the default settings and automatic formatting tools of their word-processing program or make only minor adjustments.

Paper Format - APA Style

No matter what type of APA paper you are writing, you should include four key sections: a title page, an abstract, the main body of the paper and a reference section. Title Page The title page should contain a running head, the title of the paper, your name and your school affiliation.

How to Start Writing an APA-Style Paper

General APA Guidelines Your essay should be typed and double-spaced on standard-sized paper (8.5" x 11"), with 1" margins on all sides. Include a page header (also known as the "running head") at the top of every page. For a professional paper, this includes your paper title and the page number.
